Unsubsidized yield does not adjust for any fee waivers and/or expense reimbursements in effect. Distribution Yield is the measurement of cash flow paid by a fund over a year. Yield to Maturity (YTM) is the total return anticipated on a bond portfolio without the issuers actually defaulting. Average Coupon is the weighted average coupon rate of each bond in the portfolio. R-Squared is a measure that represents the percentage of a portfolio's movements that can be explained by movements in a benchmark. Beta measures volatility in relation to the fund's benchmark. Alpha measures the difference between a fund's expense reimbursement. Standard Deviation measures the degree to which a fund's performan

The Morningstar Rating TM for funds, or "star rating", is calculated for managed products (including mutual funds, variable annuity and variable life subaccounts, exchange-traded funds, closed-end funds, and separate accounts) with at least a three-year history. Exchange-traded funds and open-ended mutual funds are considered a single population for comparative purposes. While the 10-year overall star rating formula seems to give the most weight to the 10-year period, the most recent three-year period actually has the greatest impact because it is included in all three rating periods. Morningstar rated the Short Duration Income Fund Institutional and Investor Class shares 5, 4 and 4 stars, among 534, 494, 359 Short-Term Bond funds for the 3-, 5- and 10-year periods ended 3/31/2024, respectively.
